Received several calls from Secretaries inquiring about Acting

Was approached by a Member to see if anything could be done to alleviate parking problems. I have discussed the problem and am, at present, awaiting a reply.

Attended our Annual Christmas Party, met with many of our invited guests and did a bit of PR work (I hope) for the Union. Received many positive comments from our invited guests and feel that a good time was had by all.

I would expressly like to take this opportunity to express my thanks to Léonne Kemball, Our Office Manager for her co-operation and hard work during 1986 and for the time she personally devoted to ensuring that our Christmas Party was such a huge success.
