wELFARE COMMITTEE REPORT: Submitted by Neil Clarke, Representative Local 70125 Monthly Meeting - June 16, 1986

The Department of External Affairs will very soon circulate a new policy on smoking in the workplace. Certain areas will be restricted to non-smoking, and there will be a procedure for offices to decide on needs of non-smokers in their environment. We expect voluntary compliance and hope to "iron out" specific problems in the Health and Safety Committee. All of the terms of the policy conform to PSAC policy where possible.

I attended a meeting on May 28 where the Health and Safety Committee was briefed on the new law re: Occupational Health and Safety under Part IV of the Canada Labour Code. The overall thrust to employees is:

- 1) the right to know of hazards
- 2) the right to refuse work
- 3) the right to participate in health/safety committees
- 4) the right to expect the employer will ensure protection.

Some concerns:

- it is unclear how or if the legislation will apply to our members at posts. It was admitted that this should have been settled long ago;
- Treasury Board (as responsible employer) is making implementation in the public service difficult because of its centralizing nature, and lack of funds, person years. They are supposed to be training management in the changes.
- Supervisors, and to a lesser extent employees, can be held liable to fines and charges if the provisions are not complied with. (e.g. posting of information; reporting of accidents; cooperation with Labour Canada officers investigating problems)
- as these provisions are very complex I cannot outline all details here. Through the Health and Safety Committee, I will try to keep the Local informed of important points. Should there be any specific questions or wish to have copies of documents, please contact me at 996-4638 (BICO A-3).

In conclusion, the employer has made difficult the implementation of what are good health and safety provisions. We on staff side will have to be vigilant especially in our involvement with the reconstituted Health and Safety Committee's new responsibilities.
