5. BUSINESS ARISING FROM MINUTES

B. Kemball queried if letter to PSAC President, P. Samson re: Board of Directors Meeting held in Vancouver, had been sent. D. Delaney replied in the negative but that it would be done next week.

Re: SCY Group report concerning length of SCY group postings. Hal Ade asked if a similar survey had been done for other group. D. Delaney replied in the negative. He pointed out that the SCY group had a different terms of duration of positings.

6. CORRESPONDENCE

<u>Item 26</u>, March 2 - re: Carbonless Copy Paper

David Delaney explained that carbonless copy paper was being used in the Dept. and that the International Labor Organization had a hazard warning issued early this year. It was one of the item we had discussed with the Health & Safety Officer to review. I have received numerous complaints from members using this paper. We have asked that before future distribution of this paper, and injuction be placed on the paper or that Health & Safety Unit issue a warning to the employees about possible danger of using this paper.

We have reported this matter to the National Component and the matter is being pursued.
