# 7. REPORTS:

The President, Gary Doherty verbally reported that he did not attend the last EAJC meeting on November 6 as his duties with the Department would not permit it. The Local was represented by Barry Kemball. It was also attended by P. Fortune, L. Fucile and D. Delaney. Brother Phillips attended as an observer.

Gary Doherty also reported on the OFL Convention in Toronto that he attended as this Local's delegate. He participated in caucus and on the floor of the Convention.

As a follow-up to my previous report regarding the GSMES 02 Mrs. DeGiovanni and Bob Murray were interviewed on CBC Television to support their cause on no layoffs.

I attended the EAJC meeting on November 6 when lay-offs and surplus

notices was the top priority of discussion.

On November 12 I attended a meeting called by management with the FSMES on an up-dating of their situation. I have prepared for the Local file a detailed report of the meeting. The bottom line was that some 21 appraisals had to be redone mainly because the supervisor had not been in place long enough to have prepared them. As of Thursday Nov. 14/85 the employees affected had not been made aware of their new appraisals and, as well the MES positions in Paris, Washington and MGT had to be made part of the equation.

On November 14 I called a meeting of GSMES comunicating with Brothers Fortune, Bird, Phillips and Sisters Chilton and Starchuk. A detailed report has been prepared. The grievance procedure being the primary subject. I will be attending the November 25 meeting called by management. On November 13 I attended the Ottawa-Hull Area Council meeting which had Larry Katz of CUPE as guest speaker. Two documents, one entitled "The Facts File" and the other "How to Run an Effective Campaign" are available in the Local Office for information.

The Regional Action Committee will be holding a general meeting at the RA Centre November 25 - the main subject being lay-offs and cutbacks with Brother Burke as one of the guest speaker. Please get involved and attend.

The OHAC Christmas party is upcoming for all members of the Local.
