MINUTES OF SPECIAL MEETING
DISCIPLINE COMMITTEE - LOCAL 70125
December 16, 1991

Eunice Dubé, President called the Special Meeting to order at 7:30 p.m.

Before dealing with the issues of the Discipline Committee, Eunice Dubé reminded the members present that the Mint is on strike and intend keeping a 24-hour picket line. She asked the members to give as much support as possible. Eunice Dubé intends to recruit as many members as possible from the Department of External Affairs to march with the Sisters and Brothers from the Mint i.e. one noon hour. She also asked that everyone "bank" their pennies and loonies until the strike is settled.

Eunice Dubé invited Neil Clarke to give a briefing on the results of the Solidarity Committee.

Brother Clarke reported that \$9750 dollars had been distributed as grants to members: there were 40 applicants, 75 applications (only one application was refused). Sister Ryan still has \$764.00 available and the Local Strike Fund the sum of \$1800.00.

Neil Clarke thanked Sister Prisca Nicolas and Brother Corrie Pyl for their assistance.

MOTION: Neil Clarke, seconded by Prisca Nicolas.

BE IT RESOLVED that the Local 70125 Solidarity Committee be dissolved as of January 10, 1992 and that any further request for assistance be administered by the Executive of Local 70125.

Carried.

Sister Eunice Dubé transferred the Chair to Patrick Fortune, Chairman of the Discipline Committee.

Brother Fortune explained that this Discipline Committee was formed to make recommendations on behalf of Local 70125 regarding discipline for Members who crossed the picket line during the PSAC Strike and to study what course of action to pursue. A letter to the members who had repeatedly crossed the picket line was issued to them on November 18 with a November 29 deadline for their response to the Committee. Brother William Gloss and Brother Tom Rainboth were much involved in collecting evidence. Local 70125's recommendations will be forwarded to the National Component who in turn will turn the matter over to the National Board of Directors for a final decision.

Please note: Only the PSAC Board of Directors have the power to revoke membership which is scheduled to meet at the end of January 1992.

Patrick Fortune and his committee suggest for members who supported the members on the line for a week or 10 days, no action be taken. The list of members who repeatedly crossed the picket line is 251 members.

Herewith is the recommendation of the Committee:

250 members to be suspended for five years:

1 member for 1 year (a term employee whose contract was being negotiated for renewal).

A letter to be drafted by the Committee and then the final version will be signed by the President of Local 70125 and forwarded to the National Component.

Much discussion followed.

MOTION: Patrick Fortune, seconded by William Gloss

BE IT RESOLVED that the Discipline Committee be dissolved on January 5, 1992 and that future cases be dealt with by the Executive of Local 70125.

Carried.
